| <a href="#">CA SB 1459</a> | <p>Animal shelters: veterinarians.<br/> (1) Existing law governs the operation of animal shelters by, among other things, setting a minimum holding period for stray dogs and cats and requiring animal shelters to ensure that dogs and cats, if adopted, are spayed or neutered. This bill would require public animal control agencies or shelters located in a county with a population greater than 400,000 to update any data that they make available on their internet website at least once per month, and would require those agencies and shelters to publish specified information on their internet website, including the number of animals taken in during the prior month and the outcomes for animals over the prior month. | <p><a href="#">CA SB 1479</a></p> | <p>California Agritourism Promotion Act: agritourism civil liability. Existing law provides for the direct marketing of agricultural products, including through certified farmers' markets. Existing law generally provides that everyone is responsible, not only for the result of their willful acts, but also for an injury occasioned to another by that person's want of ordinary care or skill in the management of their property or person, except as specified. This bill would enact the California Agritourism Promotion Act and would define "agritourism activity" as an activity carried out on a farm, ranch, or other rural land whose primary business activity is agriculture or ranching and that allows members of the general public to view, enjoy, and participate in rural activities, as provided. The bill would require an agritourism professional to include a warning notice on signs at the agritourism location and in certain contracts, as specified.
